Purposes and legal bases of the processing

- Where applicable, personal data contained in the job interview documentation

- If you have a professional social network account (e.g. Xing, LinkedIn), data from your publicly available profile page, if necessary

Sharing of your data

Staff responsible for the implementation of the contract from the order processing, internal sales and field sales departments, as well as colleagues from the respective departments, will have internal access to your data. Your data can be forwarded to other groups of companies and to distributors cooperating with us.

Transmission of personal data to a third country

We have no intention of transmitting your personal data to a third country.

Duration of storage

Your personal data will be stored as follows after collection:

- 1. for the duration of the application procedure;
- 2. if your application was not successful, your data will be stored for as long as we require it for the clarification of inquiries or contentions after communication of the rejection decision:
- 3. if you have explicitly consented to us considering your application for future job advertisements as well, your data may be stored for a longer period;
- 4. if there is a corresponding statutory obligation to store the data for a longer period, your data will be stored for the duration of this statutory period.

After the lapse of the storage purpose or expiry of a legal storage period, we shall delete your personal data in accordance with legal provisions.
